**REGIONAL DISTRICT OF CENTRAL KOOTENAY
BYLAW NO. 1808**

*A bylaw to delegate Development Permit approval authority
to the Manager of Development Services*

WHEREAS The Board of Directors of the Regional District of Central Kootenay has adopted the Kootenay-Columbia Rivers Official Community Plan being “Bylaw No. 1157” and the Creston Valley Official Community Plan being “Bylaw No. 1575”;

AND WHEREAS pursuant to provisions of the *Local Government Act*, the Board of Directors may delegate its powers, duties and functions to its officers or employees;

NOW THEREFORE, the Regional District of Central Kootenay Board of Directors, in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited as “Regional District of Central Kootenay Delegation Bylaw No. 1808, 2006”.
2. The Board of Directors of the Regional District of Central Kootenay hereby delegates authority to issue Development Permits in the area covered by the:
 - Kootenay-Columbia Rivers Official Community Plan Bylaw No. 1157;
 - Creston Valley Official Community Plan Bylaw No. 1575;
 - Kootenay Lake Portion of Electoral Area A Official Community Plan Bylaw No. 1978;
 - Slocan Lake North portion of Electoral Area ‘H’ Official Community Plan Bylaw No. 1967;
 - Kootenay Lake and Lardeau Valley – portion of Electoral Area ‘D’; Official Community Plan Bylaw No. 1996;
 - Regional District of Central Kootenay Electoral Area ‘K’ – The Arrow Lakes Official Community Plan Bylaw No. 2022;to the General Manager of Development Services..
3. An applicant is entitled to a reconsideration of a delegated decision by the Board of Directors.
4. The procedures for reviewing a reconsideration request are established as follows:
 - a) A delegated decision will be reviewed by the Board of Directors if an applicant submits a written request to the Secretary of the Board;
 - b) The request for reconsideration will be placed on the Board of Director’s Agenda;

- c) An applicant making a request for reconsideration, may appear before the Board of Directors to explain their appeal, provided they request the appearance in writing.
5. The Regional District of Central Kootenay Delegation Bylaw No. 1640, 2003 is hereby repealed.
